## The General Counsel and CSR: Navigating your Company in the New Paradigm

An recent article on Forbes.com described the evolution of CSR as "a nice-to-have silo to a fundamental strategic priority for businesses large and small"<sup>1</sup>. In recent years, as expectations for responsible business conduct have grown, we have seen a legislative cascade by which corporate ethics has increasingly become the domain of compulsory corporate disclosures, including around slavery in the UK, supply chain transparency in Europe and California, and human rights due diligence in France and The Netherlands.

In 2017, companies face an ever challenging matrix of social expectations and "soft obligations" becoming "hard obligations" in the CSR space, and the responsibility of navigating a company through this maze now increasingly rests on a general counsel's shoulders.
